2. Consequent upon introduction **Group 'B' (Postal & RMS) - HSG-II, HSG-I and HSG-I (NFG) category**, HSG-II, HSG-I and HSG-I (NFG) employees in Postal and RMS offices will not be part of existing Group 'C' Postal (excluding Postmen and Group C RMS including MMS).

3. Competent Authority has also decided that the nomenclature of category name, Circle Office **Administrative Staff Group 'C', 'D' and MTS** shall be renamed as Circle Office **Administrative Staff Group 'B' 'C' and MTS**.
