All HCOs,

Numerous grievances have been reported at MoHFW and at this office against the functioning of HCOs. To provide better services to the CGHS beneficiaries, the following instructions are to be followed strictly by all HCOs failing which necessary action will be initiated in accordance with the MoU.

- 1) Cashless CGHS facility is obligatory for all Pensioners & CGHS staff. There is no provision to take deposit from the Pensioners & CGHS Staff at the time of admission.
- 2) Name of the Nodal officer & contact number are to be prominently displayed. Any change of nodal officer or the contact number of the Nodal officer must be communicated to CGHS Office and necessary changes must be made in the display by the respective HCO.
- 3) Establish a dedicated CGHS Kiosk (Help desk) for the convenience of CGHS beneficiaries.
- 4) Memo for emergency cases is not required.
- 5) Rubber stamp is not required on OPD / Admission memo.
- 6) Double billing is strictly prohibited.
- 7) At any cost there should not be harassment of CGHS beneficiaries.
- 8) CGHS original card should not be retained by HCOs during the treatment.
- 9) Quotation for unlisted investigation(s) / procedure(s) should be given to the beneficiary on request. If the said test / procedure is not done at the concerned HCO, the same may be given in writing.
- 10) Retired Air India employees with valid CGHS card are eligible for cashless treatment at all CGHS empanelled HCOs.
- 11) CGHS beneficiaries aged 75 years and above shall be permitted to seek direct OPD consultation from all empanelled HCOs without referral from CGHS Wellness Centre.
- 12) CS(MA) beneficiaries and their dependent family members can get treatment at CGHS rates.
- 13) Prescriptions should strictly adhere to the government's policy by being a generic format.

In case of any complaint regarding excess billing / advance payment/ harassment of CGHS beneficiaries is received in this office, necessary action will be initiated as per MoA. Please submit compliance report within two weeks that all the above guidelines are followed scrupulously.

The following suggestions were brought to the notice keeping in view of preventive vigilance measures which will help to reduce frauds in Post offices. The following issues have been raised in the 2022 periodical meeting but there is no progress till date.

Discontinuing the concept of Impression of Date Stamp in Pass Book. Many drastic developments took in place in Banking Procedures of India Post and other Financial Institutions. No other Financial Institutions are following the concept of impression like date stamp in Pass Book. Even the IPPB Transactions have been done in Post Offices without the concept of Pass Book. **The Pass Book and impressions in the Pass Book has become the tool for the culprits to fraud, portraying the date stamp impression as authenticity of transaction and deceiving the customers.**

- Date stamp impressions can be wrongly claimed.
- In some fraud cases customers also used to add additional zeros to increase the amount and causing loss for govt exchequer and also increasing share of loss recovery to the official in the name of contributory negligence.
- Things are going smoothly based on trust in postal department but nowadays scenarios are changed and even public are involving in defrauding the Government taking the advantage of loopholes in the Rules.

As the system of Banking rapidly changed, authenticity to the Pass Book and impressions in the Pass Book had no meaning in the present trends of Banking that had been practiced in market. Requesting to review the aspects keeping in view of other Financial Institutions and IPPB etc. Otherwise Rules related to fixing responsibility based on the date stamp impression in the name of contributory negligence may be deleted from the departmental volumes.

Hence my Federation requests the authority to pursue above issues on priority and also requested to make necessary modifications/changes in the software/Rules.

An early action will be highly appreciated.

- i. PA(SBCO) officials opting to switch over to PA(PO) cadre shall be placed below all the officials who are holding the post in PA(PO) cadre on the date of issue of order for such switch over by the Circle.
- ii. In case orders for two or more PA(SBCO) officials are issued on the same day, their *inter se* seniority in PA (PO) cadre shall be in the same manner as in PA(SBCO) cadre

Sub:- Regarding non implementation of timely up-gradation of HSG-I officials to HSG-I (NFG) on completion of 2 years continues service in HSG-I cadre from the date of joining in Maharashtra Circle which is creating the resentment and demoralization among the operational staff-reg.

It has been observed that the many officials of the Maharashtra Circle have been upgraded to the cadre from HSG-I to HSG I (NFG) cadre vide CPMG Mharashtra Memo No STA/10-11/HSG I(NFG)/2019 dated 31.12.2020 as per the directions contained in the orders of Postal Directorate New Delhi Memo No 25-04/2012-PE-I dated 27.05.2016 and 25.04.2012-PE-I (Vol.II) dated 10.11.2027 and further ordered the posting in the posts identified vide CO memo Number Estt/Cadre restructure/NFG/2019-20 dated 31.12.2020, which already got badly delayed from long time. However, the eligible officials got their promotion to the cadre HSG I (NFG) by their virtue and working smoothly.

Already the officials of HSG-I cadre upgraded to HSG-I (NFG) deliberately deferred due to non constitution the DPC in due course. There are some examples of the officials who got upgraded to the HSG-I in the year 2014 and they have been upgraded to the NFG in the year 2021 which is set the bad example of lethargy of the administration that the operational staff could not be promoted timely though they were eligible for their up-gradation.

We would like to peer your attention to the memo of the Punjab Circle bearing No STC/10-8/NFG/2019/Vol-II dated 29.02.2024, which set the better example that they issued the order regarding promotion HSG I (NFG) cadre with utmost care by calculating the proper seniority from the date of completion of two year of service in HSG-I (Copy enclosed). We welcome the such crystal clear orders that motivate the operational staff.

My Federation always demands such transparent orders from all the Postal Circles which may be issued immediately without any delay tactics in welfare measure of the operational staff. That will be better motivation for the Postal Employees which will be beneficial for our Departmental business achievement in future also, because, presently the major leader among the operational staff for business development is NFG cadre which may not be deprived from their genuine rights.

It is therefore, My Federation demands the revised orders in r/o the HSG-I (NFG) may please be issued immediately w.e.f the date of 2 years completion in HSG-I cadre, so that the staff will get natural justice and motivated.

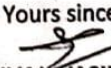

in Department of Posts-Reg.

It is to bring the following for kind notice of Honourable Minister regarding limited Compassionate Appointments in Department of Posts. As per existing policy there are many limitations, conditions and eligibility criteria for Compassionate Appointments in Departments of Posts unlike in some of the other Central Government Organizations.

Employees of DOP are the exclusive man power without reach to the Rural Areas of the Country under the purview of Essential Service and who had worked during the Covid Pandemic Period also to their possible extent.

The existing policy on Compassionate Appointment is having applicable conditions and ceiling of 5% of the vacancies raised due to demise of the employees. It means 95% of families of the deceased employees are not getting compassionate appointment with their livelihood decided by the destiny consequent on loss dependable family member.

In particular it had become a curse to the families of the employees who lost their family during the Covid Pandemic Period. Loss or demise of dependable family member in service due to any reason is big upset the family of the Employee. 5% Ceiling on Compassionate appointments is curse and big loss to the remaining 95%.

Keeping in view of above facts my Federation request the Honourable Minister to re-examine the policy and lift out the ceiling, conditions and criteria on Compassionate Appointments. It is also requested to consider all cases of the officials who died during covid as a special case.

Department of Posts is a Major Central Government Organization with its vast network and huge manpower contributing for Financial Inclusion by propagating the schemes of Central Government up to the nook and corner of the Country. The officials had worked their level best even in Covid Pandemic Periods.

The Medical Facility provided to the employees of Department of Posts is having more clutches when compared to the other Central and State Government employees like Railways/State Government Employees. Many of the employees of Department have been working in Rural Areas where there will be lesser medical facility and CGHS Centres will be far away and do not cover as per the prescribed jurisdictions of CGHS Wellness Centers.

There are many procedural clutches like identification of hospital by Central Government, prior intimation to the concerned authorities, permission from the authorities and getting advance from the authorities which will be difficult to be pursued and adopted by the near relatives of the employees in case of emergency and sometimes causing delay in treatment in emergency conditions also with much psychological embarrassment.

Many of the Postal Dispensaries are converted as CGHS Wellness Centers, but there are limitations that there is a jurisdiction for coverage under a CGHS Wellness Centres that means the CGHS are not fulfilling needs of the employees working in Rural Areas.

Now a days the General Public of the country are also getting better medical treatment at Hospitals of their choice with the welfare policies have been introduced by the Central Government like Ayushman Bharath and State Governments like Arogya Sri in Andhra Pradesh and Telangana States with cashless treatment options.'

As per the existing procedures much man power from submission of bill to the payment of bills has been utilized in the name of scrutiny, eligibility, availability of funds etc. In spite of this the officials are not getting full reimbursement of amount what they have spent.

At this juncture it is to request august Honourable Minister to examine and implement the proposal for issuing Cashless Treatment Cards like Ayushman Bharath without ceiling on reimbursement amount to all the employees of Department of Posts including Grameen Dak Sewaks.
