

Sub: - Violation of rules – exceeding the delegated powers to the SPOs Darbhanga division under Bihar circle - regd.

My Federation wish to bring to the notice of Hon'ble D.G Posts that the SPOs Dharbanga Division under Bihar region issued orders that "If any official not followed instructions issued through whatsapp and not give response disciplinary action will be taken on such official." Copy of SPOs letter dated referred above is also attached for reference.

This is the position of a SPOs and powers in so far as issuing a circular on his own that too insisting something that is not in our sphere of work and obligation in service matter. It is our choice and can't be any compulsion which is nothing but infringement of personal liberty and right to live peacefully out of office work something guaranteed by the Countries Constitution.

It is not warranted by any law in the land that one should own a phone, that took a mobile and more specifically a phone with Android formation with specific requirements to have Whatsapp. It is our choice to own one such gadget for our intended purpose of domestic or social limitation.

There is obligatory provision in any service law that we must have phone for a inter reactive communication. No such status has been assigned in any Postal Manuals. The work of postman where the nature of work involves App in phones is different and the cost and posse of gadget are departmentally funded.

The SPO's Dharbanga has overreached his powers and usurious a sky high power on himself violating code of conduct meant for a Divisional Head. His excesses breaching his competency as per the delegation of powers vested with SPOs should be focused and disciplinary action to be taken against him as per rule in Rule 93 of Volume VIII.

Hence I request the Hon'ble D.G Posts, kindly intervene in this issue and instruct the competent authority to take disciplinary action against the SPOs Dharbanga for violation of rules and it is also requested to issue suitable instructions to all authorities.

- The Cadre restructuring process completed and first LSG promotion list was released in 2018.
- 2. Due non observing prescribed procedure while holding DPC for LSG, several OA's filed before the Honble CAT Hyderabad and after examining all aspects CAT Hyderabad directed the CPMG Telangana to review the selections and rectify lapses if any. And also directed that those who already joined in LSG cadre they should continue on provisional basis. Accordingly many of the officials promoted were joined in 2018.
- 3. Instead of doing so the CPMG has cancelled the selections made earlier and issued fresh promotion list altering the seniority too.
- 4. Meanwhile the Hon'ble CAT Hyderabad in an OA directed that the date of joining is the criteria for fixing the seniority and those who were seniors in the selection list and not born in the establishment can't claim seniority. It is now settled that the criterion for fixing seniority in gradation list for LSG cadre is that the date of actual joining.
- 5. After cancelling the two lists they made fresh selections and promotion orders were released for the year 2018 and 2019. A draft gradation list was released which was not circulated to the officials where the notional seniority was fixed. My Federation wishes to bring the following issue for persuasion of the authority.

Large number of PAs have been recruited through Promotion and through direct recruitment (mission recruitment) in the last two years. But training has not been held to that phase due to non availability of seats at concerned PTC's..

Due to this services of the PAs could not be utilized completely, as untrained PAs not to be engaged with sensitive branches as per the existing rules. There were PAs who were not trained more than a year and their services being restricted to non sensitive branches. The services of these officials could not be utilized optimally though acute shortage of staff is prevailing and the official is available to discharge duties.

In this connection my Federation request to impart induction training to the newly recruited PAs at local WCTCs by hybrid mode (some subjects physically and other through online from PTC's) on priority basis there by the services of the officials could be utilized on par with regular PAs.

An early action will be highly appreciated.

Sub: - Modifications in Recruitment Rules of IP Examinations &&&&&

This is regarding request for amendments in Recruitment Rules of IP Examination.

Previously 5 Years of Qualifying Service as PA was there for eligibility of LDCE IP Examination. The spirit behind the qualifying service in feeder Cadre might be to get experience in Departmental Work. But when the 33.33% of the Vacancies have been allowed from Direct Recruitment to IP, the spirit and purpose behind the word of Qualifying Service in feeder cadre is almost defeated.

At this juncture, increasing the eligible Qualifying service from 5 years to 8 years do not serve any purpose. Hence it is to request to amend the RRs to reduce the qualifying service from PA to LDCE IP to 5 Years as was there previously.

- 2) During the Past, much number of Ex-Servicemen has been recruited as PAs in CGL. Due to maximum age limit of 40 Years many ex-servicemen officials are, losing the opportunity to appear for LDCE-IP Examination. In this connection it is to request to Relax the maximum age limit for the Ex-Servicemen PAs.
- 3) After Cadre Restructuring in Postal wing many juniors were promoted and consequent on merger of PM Grade cadre with general lane in future there will be stagnation in promotions. The Operative Staff of Department of Posts much disappointed since decades because of two lines of promotions separately for Operative Line and Administrative Line. To avoid this and to safeguard future promotion chances a common gradation list of HSGII/HSG1 and IP Cadres to be maintained as both are Non-Gazetted Group B. There by differentiation and discrimination between the Operative Line and Administrative line will be vanished and the Promotion Structure will be become comprehensive. It also avoids stagnation in promotion channels of Operative Staff.


- 1. IP with 5 years of Regular Service in prescribed scale are eligible for appearing LDCE of PSS Group B Examination. The term Regular Service clearly means that the service rendered by the officials from date of joining to the date of Notification. Considering the period before joining into the department as Service is not legal. It is well known that even in promotional DPCs also Administrative Delay in conducting DPCs will not be considered and delayed period will not be considered as service in promoted cadre though it happens purely due to Administrative Reasons. But the decision in this case happened in contra.
- 2. As per the Existing PSS Group B RRs for any relaxation it is to be consulted with UPSC.
- There is an inequality between Seniority quota and LDCE quota while calculation of vacancy position. This should be rectified keeping in view of natural justice for candidates appearing for Gr B examination.

In this connection it is to request to disclose the Administrative Reasons lead for cancellation of the examination to uplift the procedural fairness in the LDCE System. It is to request to review and re-examine the decision basing on the existing rules and practices being implemented in the Department.

- 9. GDS Rule3 and recruitment policy is changing two half yearly instead quarterly. Inthis view of circles are under examination.
- 10. Regarding RTP court case implementation, Financial implication calculation awaited from circles.
