

HISTORICAL STRIKE OF CG EMPLOYEES AND WORKERS ON 19TH SEPTEMBER 1968 56 years are over after the great historical one day token strike of the Central Government employees which took place on 19th September 1968.

It was a strike which shook the government and the country. More than 30 lakhs of CG employees participated keeping the country to a standstill. The P and T, Railway, Defence and other employees with their strategic position ensured that the entire machinery of the central government was paralyzed.

It was a struggle for the dignity of labour, for the 15th ILC approved Need Based Minimum Wage, for full neutralisation in cost of living through Dearness Allowance and such other demands. The demands were well understood by the workers despite false propaganda of the government.

The Union Government used the hated Essential Service Maintenance Act and other such anti-worker ordinances to suppress the struggle, instead of conceding the just demands of the workers. The workers did not flinch; they had the bitter experience of the 1960 strike which was treated as 'Civil Rebellion' and tried to be suppressed by the then Prime Minister. The workers had understood the anti-worker policy of the government, which was only to support the rich and ignore the justified demands of the workers.

It is to the credit of the Left Government of Kerala, headed by Com.E.M.S.

Namboodiripad, who declared that his government will not use the ESMA against the striking government employees, despite warning of the central government that failure to implement ESMA may result in dismissal of his government.

Thousands of workers were arrested, jailed, terminated, suspended, dismissed and heavily victimised. CGE unions were derecognised. The heroism shown by the ordinary workers was beyond description.

Many years have passed since then. The employees are now getting DA automatically, whenever there is an increase in the cost of living. Strike victimisation has come down. Usually only dies-non is issued for participation in the strike, except in isolated cases. But still we are to get Minimum Wage implemented as per Dr. Akroyd formula which is around Rs.26,000 at present.

The present government has completely ignored the just demands of the CG employees

and workers. Demands like Restoration of Old pension Scheme, Appointment of VIII CPC which is due, Additional pension after 65/70/75 years, Increase in FMA etc. are denied without any justification. Hard-won rights of the workers are taken away to favour the corporates and the rich.

On this 56th anniversary of the historical strike, we pay homage to the 17 martyrs of the 1968 September 19th Strike, who sacrificed their lives for the future generations. The great leaders who led the strike, the workers who implemented the call - we remember all of them, some still in the movement, all of them retired and some no more with us. We will always remember those comrades who were part of this great struggle and contributed for a better future for the working class. Their inspiring memory will certainly strengthen our future struggle for justice to the CG Employees and Workers!

## All Confusion Cleared on Unified Pension Scheme: -

- 1. Contribution: 10% of (Basic+DA) from Employee, 18.5% of the same from Government.
- 2. Fund in two parts: -
- First Fund 10% of Employee & 10% of Government total 20% of (Basic+DA) will be invested in Default/Conservative/Moderate Market linked Scheme by individual choice same as NPS.
- Second Fund 8.5% of Government contribution will go to any fixed income source decided by government.
- 3. Default Fund: Assured pension is based on 'default mode' of investment pattern notified by PFRDA i.e. equal amount of investment in all three public pension fund managers (SBI pension Fund, UTI Pension Fund & LIC Pension Fund) in which 85% invested in fixed income source such as Government Bond & Corporate Bond and 15% invested in equity market by these three fund managers.
- 4. Individual Fund choice Subscriber can also choose any of the fund belongs to three categories Default (85% Bond + 15% Equity), Conservative (75% Bond + 25% Equity) and Moderate (50% Bond + 50% Equity) in conservative and moderate there are many public and private pension fund managers.
- Minimum Pension: This is minimum pension assured which is average of 12 months of basic pay prior to retirement taken into consideration plus Darenes Relief at the time of retirement. (50% of Basic+DR)
- Corpus: Total accumulated amount in First Fund of UFS including return on investment at the time of retirement. (Employee + Government contributions & Return on that investment)
- Annuity: An insurance contract issued and distributed by financial institutions with the intention of paying out invested funds in a fixed income stream in the future.
- 8. Government Promise: Government promised minimum pension based on default fund if 100% of total corpus is annuitized. If pension after annuity is more than assured pension due to individual choice of fund or good market conditions employee is entitled to such higher pension. Any shortfall in minimum assured pension after annuitization of 100% of corpus due to poor market conditions the government will compensate that shortfall using the 2nd fund i.e. from fixed income fund in which government contributed 8.5%)
- 9. Withdrawal: Up to 60% of total Corpus can be withdrawn by employee at the time of retirement the assured minimum pension will be reduced proportionately. Government will only compensate shortfall taking into consideration of 100% annuitization of total corpus not less than that. This will work similar as Commuted Value of pension in Old Pension Scheme.
- Lumpsum: Government will provide a lumpsum amount, other than gratuity, of 10% of monthly emoluments for every completed six months of service.





On 11.09.2024 Periodical meeting held with FNPO affiliated unions. Secretary Post, DG Post and other officers also present. Highlights of the meeting given below and full details will be published after receipt of minutes from the SR section.

- 1. Our long pending demand upgradation of C class offices into double handed offices agreed with rationalisation of post offices. Where world load is there staff will be retained and additional staff also given from deploying less work load offices.
- 2. GST/IT returns filing work will be given for private consultant at circle level instead DDO.
- 3. Discontinuation of date stamp already exempted for computerised PBs vide SB order 10/2012 and for remaining also reviewed once the features of eKYC etc are implemented.
- 4. NDC delivery staff problems will be reviewed including distance and no of articles. Permanent staff will be attached.
- 5. Regarding dress allowance item clarification already given.
- 6. Proposal will be sent to include RMS offices also a part in Amrith Bharat scheme and proposal submitted by FNPO.
- 7. Civil wing will be strengthened keeping in view of 1000 offices look and feel project.
- 8. Civil wing cadre restructuring will be finalised soon. After cadre review posts also will be filled like JE Jr Draughts man etc.
- 9. Implementation of common court cases for all issues will be reviewed and will decide case by case.
- 10. Cashless treatment issue will be referred to Health Ministry
- 11. Keeping inview of MMU related issues substitute should be provided in leave vacancy for short leave spells also and existing orders will be recirculated.
- 12. Creation of supervisor union matter is in court. Hence no final decision.
- 13. Compassionate appointments review committee will be appointed and unions also will be invited to bring changes in favour of deceased family members welfare.
- 14. All unfilled vacancies in MTS, MG, Postman in circles will be added for 25.8.24 examination results. In any circle still unfilled vacancies are there those can be filled with surplus candidates of other circles... This proposal is also under examination.
- 15. Officials in level 1, 2, 3 at Civil Wing also eligible for PA/SA exam asper new RR
- 16. Cadre Restructuring of RMS and MMS: We presented our proposal in detail, emphasizing that there would be no financial implications or functional justification issues. Our suggestion was well-received.

- 17. Norms for Register, Speed, Parcel Hub, and Letter Mail: We stressed the importance of adhering to proper norms in all these branches and demanded that they be followed strictly.
- 18. Inclusion of RMS Offices in Amrith Bharath Station Scheme: After a detailed discussion, Madam assured us that our proposal would be taken up with the Railway Department for inclusion.
- 19. Dimapur HRA Case: We discussed the issue with ADG PAP and the report from Assam Circle is being examined.
- 20. Vadodara RMS Issue: We discussed the matter with DDG (P), who has spoken with PMG Vadodara to address the issue of Circle Secretary, AIRMS.
- 21. It was informed that adequate funds will be provided for repair, maintainanc of departmental building and Postal quarters
- 22. Secretary Posts informed that department will go for big changes for it's modernization as well as for reducing the loss of the department
- 23. To take immediate steps to join sports quota recruitment officials at early date submitted letter to Secretary

Also visited Delhi circle and met DPS HQRs about Delhi Spl recruitment drive 2022 results and they informed that another 15 days time asked from directorate to finalise.

It is to bring the following Technical Issue with regard to Delivery and Postman Management System for persuasion and solution.

At present when network supports and SAP is functioning then only mail DPMS work can be done like receiving of mails, invoicing of Speed Post letters and Register post articles for delivery and returns of accountable articles and closing of mails.

Due to this in many instances mails are being held up due to power failures, network/SAP frequent failures and especially on Mondays as there usually there will heavy volume of mail. Due to this Receipt of Bags, Opening of bags, invoicing the articles to Postman/BOs and preparation of delivery invoices happens delayed beyond the prescribed hours. Consequently Delivery Staff from HO to BO Level have to start their work with much delay there by delivery percentage will adversely affect. This is causing embarrassment among delivery staff as well as other staff.

Hence my Federation requests the Hon'ble Secretary kindly take necessary steps for facilitating "Off-line" provision for work related to Delivery and Postman Management System in Project 2.0 software for better delivery performance and optimum utilization of staff hours.



At present the GDS posts are being filled on the merit basis of marks obtained in the SSC (10<sup>th</sup> class) through online engagement portal.

During Covid pandemic period some State Governments awarded 10/10 grades (100% marks) have been awarded to all the students without holding examinations and without observing their merit.

Due to above reason many of the candidates don't having minimum knowledge are being recruited as GDS BPM and ABPM. Even in the last cycle also the candidate who got state first rank also doesn't get the GDS appointment due to special relaxation given to the candidates during covid time.

It came to my Federation notice that many of the IPs/DHs raising their dissatisfaction about such GDS staff performance and due to lack of knowledge some financial irregularities also happening. All such activities are increasing unnecessary work pleasure on administration.

Hence my Federation requests the Hon'ble Secretary kindly intervene in this issue and take necessary steps for recruiting worthy candidates for the post of GDS cadre by holding some kind of merit test instead only weightage on marks in the 10<sup>th</sup> standard. I hope the authority will take proper action in this subject for the growth of the Department.
