India will provide a Field Project Expert, staff and office set up for UPU's regional office. Projects on capacity building and trainings, improving efficiency and quality of postal services, enhancement of Postal technology, e-commerce and trade promotion etc will be prepared and implemented for the region by this office in coordination with UPU.

The initiative would help expanding India's diplomatic footprint and strengthen relations with other countries, specially in Asia-Pacific region and will enhance India's presence at the global postal forums.


